I would love to include something you write to share. I will only include your name if you tell me to.

Events overtake plans. Thought I should send you what I wrote to local pastors and leaders about what is happening in Baltimore.

Brothers,

Under Mayor O'Malley arrests averaged over 100,000 a year for a city of 600,000. Do you really think they were all legitimate? My wife had a prayer partner who was victim of an assault. She was held for nearly a day before being released on her own recognizance. I like to think it was my intervention that prevented her from being given the normal \$50,000 bail (10% down) to avoid waiting in jail for a month till trial. They sold their home in Baltimore and moved to Pennsylvania. Many took pleas, admitted guilt, to go home, time served. Now they are admitted felons. Would you offer a man charged with 45 minutes of vaginal and anal intercourse with a 13 year old "plead guilty - go home today"? The girl was a virgin when examined afterward. It was her mother's boy friend she did not like - he would not let her friends tear up the house. It took two years awaiting trial before they made the offer.

Talking with a high ranking officer - later warden - about a fellow I knew serving 40 years for a murder he obviously did not do. The only thing that I could figure was that the cops were protecting the real murderer who was paying them off while he was dealing drugs. The reply: "happens all the time." The pattern I saw was that black men doing well, job, home, etc., were especially marked to be cut down along with foolish ignorant young men. Only once did I see a known "bad dude" falsely changed. Major Drug Kingpin I personally know, mandatory minimum - life, was out in 10 years, back in business. I think he was given a deal because of who - authorities in high places - he did not tell on.

The following from the op-ed page tells what it is like. It may be possible that conditions today are somewhat better. Is the 3rd circle of hell really better than the 5th?

The Bible - God - from beginning to end is adamant against the oppression of the unrighteous against the poor. On the day of judgment Mt 25 and in other places it is not murder, abortion, prostitution homosexuality that He sets forth as damnable. It is not helping - the sin of omission - the hungry, oppressed, prisoners. (In that day there were not many 'innocent' in prisons). Those who lead worship to the true God supporting the powerful as they oppressed the widow and orphan, dispossessing the poor from their land, livelihood were denounced by God's prophets.

"To whom much is given much is expected." Perhaps because we are so right, we deserve the hottest fires instead of the most glorious crowns?

Cops and 'Black Baltimore'

There are generations of discord between police and black communities in Baltimore

The footage involving Freddie Gray and the Baltimore City cops brought it all back.

Growing up in 1990s Baltimore, some of the cops would use Black Baltimore as a playground to do whatever they wanted to do. Pre-teen years, I would hear from the teenagers and the older men in my neighborhood about the harassment, brutality and false arrests. I would watch their eyes and hear them mumble profanity at the patrol cars riding by them slowly, while the cops would make eye contact right back at them.

In my teenage years, I would start to see it for myself. Cops handcuffing you, followed with an order for you to stand in the hot sun. They would go back to sit comfortably in their patrol car with the A.C. running, eyes fixed on you, claiming they are radioing in your description, which would take them 20 or 30 minutes to complete.

The physical brutality by their hands ran rampant in the 1990s, especially in the summer seasons. Lord knows what my uncles and the fathers, older brothers and uncles of my childhood friends went through in the 1980s and 1970s, before mobile phone cameras and the Internet. Not to mention the verbal insults that you would hear from some of these cops smelling like aftershave and mouthwash: "Roaches!" "Junkie!" "[N-word]!" "Dummy!" "Shut the [expletive] up! I will lock you up if you say one more word." You could be sitting in your home, with your window up and open in Black Baltimore and hear this kind of dialogue.

Lately, this is why I have not been tuning into CNN or The Baltimore Sun online to see what the media is saying about my city. This is why 90 percent of time, I will stay quiet when people who are not from Baltimore ask me with intrigue in their eyes, "Is 'The Wire' like Baltimore?" Years ago when "The Wire" was on the air, people used to question why I would decline to watch it; I would answer, "Two white men are the creators of this show, and one is a former Baltimore City cop." I knew that I would lose them if I went into the details like I did in the paragraphs above this one, so I would stop my reasoning right there.

The media does Black Baltimore no favors in the fairness category. Either my people are hooked on drugs, romanticized as some mythical drug-kingpin or, as of recently, violent protesters without a cause. Such unfairness will instruct you to pay no mind to the progress the city has made and the history fueling today's protests: generations of blacks in Baltimore going through police brutality, verbally, emotionally and physically.

It is in my best prayers that Freddie's family heals and becomes stronger. Matter of fact, I extend that prayer to every black family who lost their loved one to police brutality. There is an element of being black and dealing with oppression that won't ever be fully expressed on television or in the newspapers, because after the camera crews leave, the inequalities somehow find a way to continue. Maybe in the future, if complete freedom does find a way to come, it will be in the form that such an element is not edited by those who do not know or understand. Maybe then they will shut up and listen.

That said, my greater source of personal concern, outrage and sympathy beyond this particular case is focused neither upon one night's property damage nor upon the acts group but is focused rather upon the past four-decade period during which an American political elite have shipped middle class and working class jobs away from Baltimore and cities and towns around the US to 3rd world dictatorships like China and others plunged tens of millions of good hard working americans into economic devastation and then followed that action around the nation by diminishing every American's civil rights protections in order to control an unfairly impoverished population living under an civil rights protections in order to control an unfairly impoverished population living under an ever-declining standard of living and suffering at the butt end of an ever-more militarized and aggressive surveillance state.

BALTIMORE (AP) — A photo editor for a Baltimore newspaper says he was beaten by police at a protest over the death of Freddie Gray.

J.M. Giordano, who works at the City Paper, says Baltimore police "swarmed over" him and hit him repeatedly. A video posted to the newspaper's website Sunday shows at least two police officers in riot gear hitting and kicking Giordano as the person filming screams, "He's a photographer! He's press!"

The 41-year-old Giordano says his head hit the ground during the beating, which he says only stopped when someone pulled him out of the fray.

Sait Serkan Gurbuz, a photographer with Reuters, says police detained him as he shot pictures of the scuffle. Reuters says Gurbuz was cited with failure to obey orders.

A Baltimore police spokesman hasn't immediately commented.
